A deposit of \$200 is required to hold the event date and is due upon the signing of this agreement. The down payment is non-refundable, but is transferable with Dakota Photobooth having full discretion of acceptance of a new date dependent on availability and the execution of a new contract. The balance is due no later than one week prior to the contracted event. If balance is not paid on time, deposit shall be forfeited and the photobooth reservation cancelled.

The CLIENT represents there is good access at the event location (no stairs or other obstacles, 120v electrical outlet within 10 feet of placement of photobooth, level/concrete-type surface, etc.) and the accessibility for photobooth delivery and setup will be available a minimum of three hours before the event. The CLIENT will be responsible for any malicious damage done to the photobooth or for any props taken or damaged by the CLIENT's guests. The CLIENT gives Dakota Photobooth permission on behalf of client and all attending guests to use their likeness for any advertising, promotion, or publications.
